# **Bequests**

A bequest is a gift from your estate—a transfer of cash, securities, or other property made through your estate plans. You can make a bequest by including language in your will or living trust, leaving a portion of your estate to your favorite charity, such as Bampa's House. Some of the advantages of creating a bequest include: knowing you are helping to ensure the continued operation of our charity; you retain control and use of your assets during your lifetime; you may modify your bequest if your circumstances change; and gifts from your estate may be exempt from federal estate taxes. Please see your legal and/or tax advisor for more information.

#### **Retirement Plans**

Donating part or all of your unused retirement assets, such as your Individual Retirement Account (IRA), 401(k), 403 (b), is an excellent way to make a gift to Bampa's House. If these types of retirement accounts are left to your heirs, your heirs will pay income taxes on all distributions that the heirs take from these accounts. Qualified charities, such as Bampa's House, pay no tax on the distributions. Leaving other types of assets such as cash and appreciated securities to heirs may be more tax efficient and leave more money in the hands of your heirs. Please consult your financial or tax advisor if you want to explore designating Bampa's House as a beneficiary of your retirement accounts.

# Gifts During Life

### Gifts from a Retirement Account

Increasingly, retired individuals are using a special kind of distribution from their retirement accounts, called a Qualified Charitable Distribution (QCD), to make charitable contributions in a taxpreferred way. Once someone reaches the age at which they must begin mandatory distributions from their retirement accounts, they can take advantage of this technique. In a QCD, the distribution goes from the retirement account directly to the charity, such as Bampa's House. As such, the distribution is not included in taxable income by the owner of the retirement account. If you have a retirement account that is subject to mandatory minimum withdrawals, you may want to speak with your financial or tax advisor to see if this technique might work for your situation.

# Gifts of Stocks, Mutual Funds, and Other Investments

If you own stocks or other securities that have gone up in value over time, you may be able to use those investments to make a gift to Bampa's House without paying any tax on the gain. The first step is to donate the appreciated stocks or other investments to a qualified charity such as Bampa's House. The charity sells the appreciated investment but pays no tax on the gain because it is exempt from paying those types of taxes. You pay no tax on the gain and get a charitable deduction for the full fair market value of the gift which could be beneficial if you itemize your deductions on your tax return.

#### **Donor Advised Funds**

If you have a donor advised fund (DAF), now is the time to use the funds to make a positive and immediate impact on a charitable cause that is meaningful to you. Giving to Bampa's House is simple: Either go online or call your fund manager and request a grant to Bampa's House. Be sure to include your name and address so we can properly thank you!


